DEPOSIT: To reserve your wedding date, a signed contract must be returned, along with a deposit of half the total videography cost. This fee is a deposit on the wedding package and as such, is deductible from the final bill. Final payment is due upon receiving the DVD.

VIDEOGRAPHERS: It is understood that Holy Daisy Designs is the exclusive official videographer. Holy Daisy Designs is not responsible for any one shot. They will do their best to meet all of the requested shots of the bridal couple.

COOPERATION: The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. Holy Daisy Designs is not responsible if key individuals fail to appear or cooperate during video sessions or for missed footage due to details not revealed to us.

MODEL RELEASE: The Client hereby grants to Holy Daisy Designs and its legal representatives, the irrevocable and unrestricted right to use and publish video of the client or in which the client may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. Under copyright law, the video cannot be duplicated for any reason. The client further agrees that any desired duplication must be made through Holy Daisy Designs. The client hereby releases Holy Daisy Designs and its legal representatives from all claims and liability relating to said video footage. The video is strictly produced for the client's private home use only. Any duplication, alteration or broadcast, including but not limited to internet use, without written consent and permission from Holy Daisy Designs is strictly prohibited. Client assumes all liability for any form of copyright infringement.

LIMIT OF LIABILITY: In the unlikely event that the videographer is injured or becomes ill to video the event, Holy Daisy Designs will make every effort to secure a replacement videographer. If the situations should occur and a professional replacement is not found, responsibility and liability is limited to the return of all payments received for the event package, and no further damages may be sought against Holy Daisy Designs for any reason. In the unlikely event that all the video have been lost, stolen, or destroyed for reasons within or beyond videographers control, Holy Daisy Designs liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of original footage shall be a prorated amount of the package selected, based on the percentage of footage lost.

DAMAGE TO EQUIPMENT: In the event any Holy Daisy Designs equipment is damaged, stolen or destroyed, either accidentally or intentionally, by the client, wedding guest, attendants or employees of the client, the client is fully responsible for the equipment's replacement at current new market prices. Also in the event if videographer is harmed or injured either accidentally or intentionally, by the client, wedding guest, attendants or employees of the client, the client is fully responsible for all costs involving the videographer's injuries. Holy Daisy Designs bears no legal or financial liability to any individual attending the scheduled event that should be harmed or cause harm to another person or property for whatever reason or cause. The client accepts all responsibilities for all guests, attendants and employees of the client and anything that may happen to them.

SECURITY DEPOSIT: In the event of cancellation, the deposit paid is non-refundable. It shall be liquidated damages to Holy Daisy Designs in the event of a breach of contract by client. Holy Daisy Designs reserves the right to terminate the contract for any reason at any time. Should Holy Daisy Designs terminate the contract a maximum of all monies paid by the client will be refunded.
